Report on Nani A. Palkhivala Memorial Elocution Competition

LATE B.G. DESHMUKH MEMORIAL LECTURE : 23rd August, 2016






ANNUAL EXHIBITIONS: IRIDESCENCE-Annual Photography & Book Exhibition: 4th and 5th February, 2017

Awards & Recognition

The CLCLC, SLS, Pune has set up permanent Legal Aid Clinic in the Yerwada Central Prison to help the undertrial prisoners there. Since its establishment, the cell has been regularly organizing medical & legal aid camps for the welfare of inmates and their small dependent children. This endeavour this year was duly recognized by the 14th Finance Commission through National Legal Services Authority (NALSA) and Maharashtra State Legal Services Authority (MSLSA) by declaring a fund for this project.

On 25th April, 2017, CLCLC won the 1st prize amounting to Rs. 5000/- in the 1st Dr. A. P. J. Abdul Kalam International Socio-Legal Film Making Competition. The competition was organized by Kamdhenu Joshi & Associates, Ahmedabad, Gujarat and ProBono India, Surat, Gujarat. 
