

FROM THE EDITORIAL DESK

Dr. Shashikala Gurpur, Fulbright Scholar, Director, SLS-P, Dean, Faculty of Law, SIU fondly remembered Late Advocate Shri Ram Jethmalani (1923-2019), in her welcome address. She recalled the vibrancy of Mr. Jethmalani's personality exuding wit and humor. She spoke about his dedication and commitment to law. Dr. Gurpur remarked how he could invoke a sense of patriotism in the hearts of all who had the privilege of listening to him. One of her fondest memories is associated with the publishing of his book 'Rebel.' The book was a collaborative effort of the faculty members and students of Symbiosis Law School, Pune. It depicted his dynamic personality and his various roles as a lawyer, a teacher and a mentor. As the chairman of the Bar Council of India (BCI), he proposed the groundbreaking idea of commencing a five-year law programme to revamp the Indian legal education system.

Following Dr. Shashikala Gurpur address, the portrait of Late Adv. Jethmalani's was garlanded and a melodious Bengali song by Rabindranath Tagore was played. The audience shown a short film on the life, achievements and contributions of Late Advocate Shri Ram Jethmalani. The next speaker, Mrs. Nalini Gera, author, also lamented the loss of a crusader in the legal field. Late Advocate Ram Jethmalani was a staunch believer of the fact that corruption can and should never be tolerated by the society. Beyond the legal arena, Mr. Jethmalani was also a religious scholar, who wrote a treatise on Islam and have a debate on Hinduism. Reflecting on her days and long hours of discussions with him, she reminisced his humility.

Adv. Harshad Niabalkar recalled on Late Advocate Ram Jethmalani's extraordinary skills as a criminal lawyer and an authority on Constitutional Law. Adv. Nimbalkar recounted the modesty and respect that Late Advocate Ram Jethmalani would extend to everyone. He went on to exclaim, "Simply put, there cannot be another Ram Jethmalani". 




