Introduction (internal departments, member strength, leadership)

Internal Department(s):

The cell currently has 4 active internal departments, which are as follows:

1. Gender Project

This department aims at creating awareness, specifically around the issues related to gender in the area of human rights, including inequality, exploitation, rights, and their deprivation in certain sections of society, through activities such as workshops, webinars, lectures, fieldwork, panel discussions, movie screenings, etc.

2. Legal Research and Awareness Clinic (LRAC)

The Department is undertaking research work behind human rights areas. LRAC aims to create legal awareness, draft research papers and articles, and carry out in-depth research on the legal side of human rights. LRAC aims to carry out activities like interviews, research papers, workshops, prompt writing, etc to fulfill their objectives.

3. Weekly Discussions

This department, through panel discussions, quizzes, and conversations, aims to make people aware of the current legal issues persisting in the field of human rights, along with getting to know varied perspectives on these issues, to come up with holistic solutions.

4. Youth Theatre

The department aims at reaching out to the masses and presenting various human rights issues, through the medium of performing arts, like creating short films, street play performances, programs, etc.

Human Rights Playlist


- 1. Addressing violence against sex workers

Ongoing activities/ Activities proposed (a brief description of the activities proposed and status of the administrative work)

The **youth theatre** department has finished its script on "Issues Faced by Transgendered Individuals" and the same is pending approval. As soon as the script is approved, the cell would start working on the shooting which would be done online due to the current situation.

The **Weekly discussion** department would conduct its first discussion in the month of February. The tentative topic for the same is "The Discontinuation of Beauty Pageants at the national and global scale". The same is yet to be approved by the faculty.

The **LRAC** department has proposed a newsletter and monthly prompts for the current academic year both of which would focus on all major and minor topics related to Human Rights and raise awareness amongst students. The same is yet to be approved by the faculty.
