The campus Placement Process is ongoing and following companies are yet to hold their recruitment/ declare results:

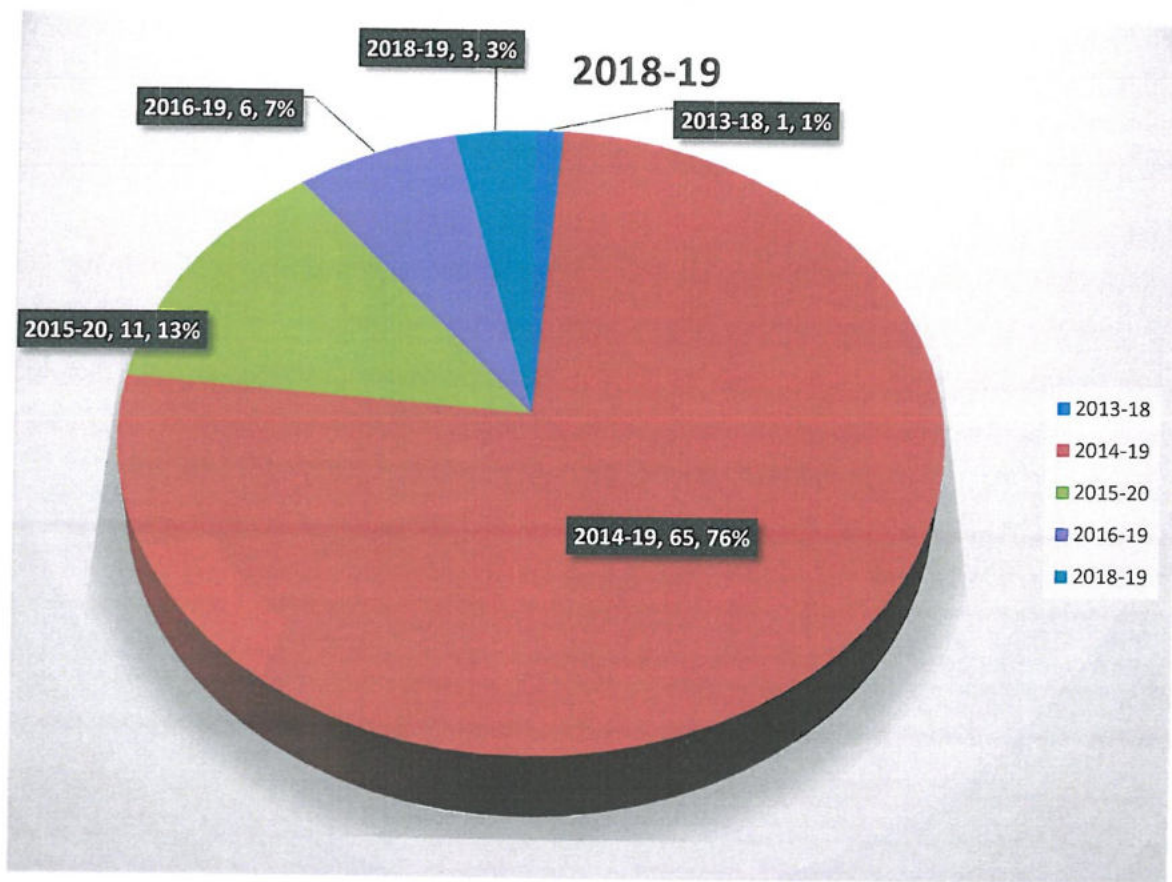

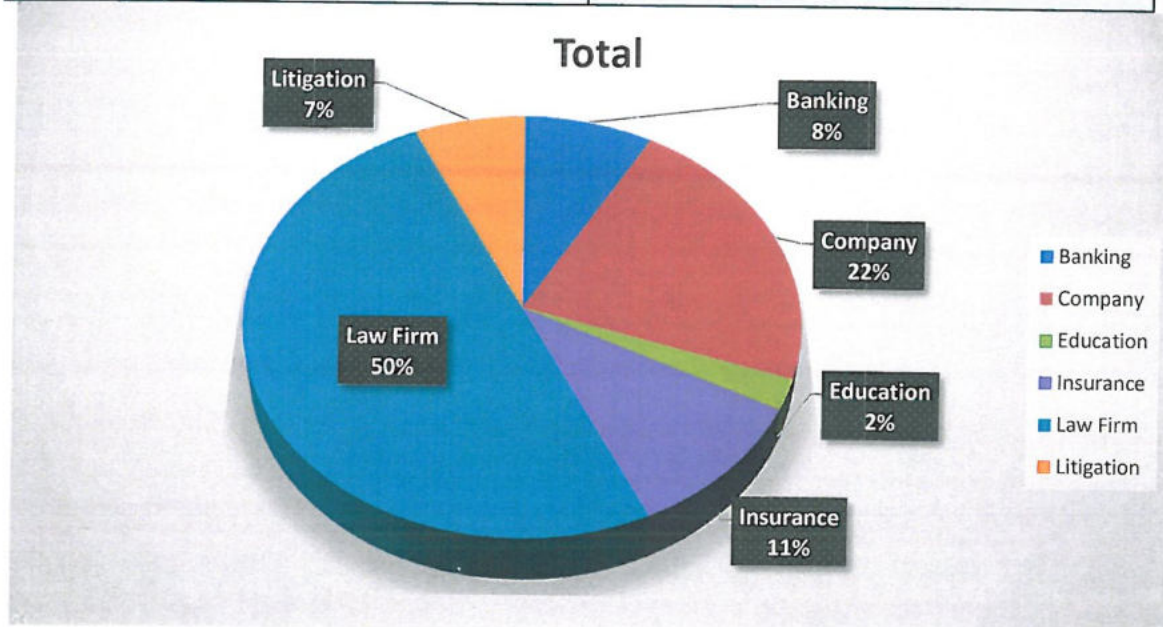
## Report 2: Placement details Sector-wise
